Deadline for limited Expo space available is June 3, 2009. Cheyenne Mountain State Park must approve all applications. The Expo fee includes a 7% fee paid to the Park. All Expo exhibitors must pay a \$6.00/vehicle per day access fee. You may purchase a pass good for June 13 on June 12. Any pass valid for June 12 expires at noon on June 13th and an expired pass results in a Park fine. This fee is not included in the fee. We recommend a pass for June 12 and 13 (two passes)

In addition, any Expo exhibitor must declare on this form if any items will be sold. Any sold items are subject to a 7% of the gross fee paid to Sand Creek Sports in cash or check (no credit cards) prior to leaving the venue on June 13th. The Sand Creek Sports Expo staff will collect this. This entire fee is then paid by Sand Creek Sports, with an accounting, to Cheyenne Mountain State Park.

Expo location is 20'-30' directly east of the S/F straight in a paved parking lot. UCI Team parking is immediately west of the S/F straight. The first paid exhibitors will face the S/F straight with only the spectators between you and the S/F fencing!

- Banner space not available on the S/F fencing
- Expo Exhibitor mention on PA during race
- Prime Space assigned on a first come basis

Expo space must be reserved in advance and either paid in advance or on-site on June 12th. Check-in is June 12th at the Park Office Conference Room 4:00 PM (tentative) to receive parking credentials, etc. Vehicle pass(s) available in Park lobby.

You may park and secure your Expo vehicle late in the day on June 12 provided you have a Park pass valid for June 12 and 13. Neither Sand Creek Sports or the Park are liable to damages or vandalism. No canopies up until June 13th! (Too windy)
